- Each Restricted Stock Unit is the equivalent of one share of Forrester Research, Inc. common stock.
- On August 2, 2021, the reporting person was granted 6,059 Restricted Stock Units that vest and convert into common stock in four equal and consecutive installments beginning on August 1, 2022, August 1, 2023, August 1, 2024 and August 1, 2025.
